Therefore, we will strive to conduct our business in an environmentally responsible manner by implementing, maintaining and improving sustainable practices throughout our business operations to lessen our impact on the environment.

To this end, we ask that all of our directors, officers and employees fulfill and advance this commitment within our programs, facilities and the communities within which we operate. We will also seek to establish and maintain mutually beneficial, long-term relationships with business partners who demonstrate a commitment to these principles as well.

We will strive to achieve this commitment by:

- Implementing and maintaining an Environmental Management System at our facilities
 to monitor and evaluate our environmental performance, and continually improve upon
 our environmental performance.
- Reducing our Scope 1 and Scope 2 greenhouse gas (GHG) emissions across all operations
 by implementing GHG reduction goals into business planning, tracking our emission
 levels, and developing a roadmap to achieve carbon neutrality in our total Scope 1 and
 Scope 2 emissions.
- **Improving air quality** by implementing reduction initiatives at our facilities to minimize emissions, as well as designing products that meet or exceed environmental standards for emission controls.
- Enhancing energy efficiency through facility upgrades that seek to minimize energy consumption across our operations and promote the use of energy-efficient equipment and systems.
- **Increasing our use of renewable energy**, where feasible, by a variety of methods to integrate renewable energy sources into our operations..
- Exploring decarbonization options in product development, manufacturing processes, and supply chain management, with an aim to reduce reliance on carbon-intensive activities.

- Improving water consumption and water management by implementing facility upgrades to reduce our water consumption and explore opportunities to promote water recycling and treatment in our operations.
- Developing and designing high-quality automotive products to be more efficient, including emission control offerings that are designed to reduce emissions of harmful air pollutants that result from the operation of certain vehicles.
- Promoting waste reduction, reuse, and recycling programs to reduce the quantity of waste generated throughout our operations, and enhance our packaging optimization and remanufacturing initiatives.
- **Empowering our employees**, through training, direction and encouragement, to be more conscious of the potential environmental impact of their individual actions in fulfilling their duties.
- Ensuring compliance with our commitments to our customers and all applicable
 environmental laws and regulations that apply to our business operations and the
 manufacture, distribution and sale of our products, including those relating to the
 transportation, storage, use or disposal of regulated materials, such as chemicals and
 hazardous substances.
